Description:

Document of a folio, consists of a court order issued by the Real Audiencia de Lima (*Royal Court of Lima*), appointing Bernabé Morante as administrator of the bankruptcy houses of Diego Agüero and Isabel de Zárate, his wife, in place of Juan de Urrea. It includes notification of this order to Andrés Camacho de Escobar, administrator of the Caja General de Censos de Indios de Lima (*General Fund of Censuses of Indians of Lima*) (21/06/1679 - 22/06/1679). The document presents a regular state of conservation, with lost areas in the foliage area, where the number "2" is distinguished; it also presents a third seal, a real, from the years 1675-1676, validated for the years 1678 and 1679. On the upper part of the round, there is a pencil symbol: "49E17299676". This is an original document (not a copy or a testimony), with the initials of the Royal Audience, in italic handwriting.

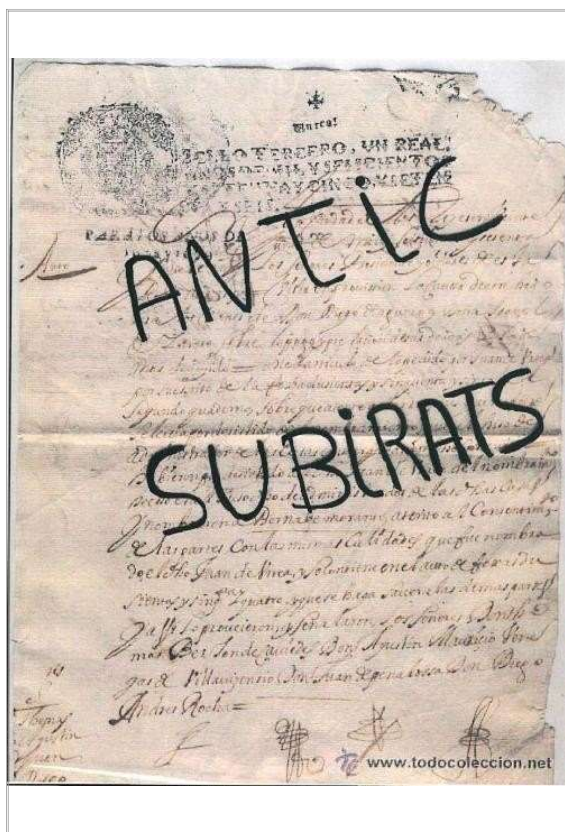


Image: Front View

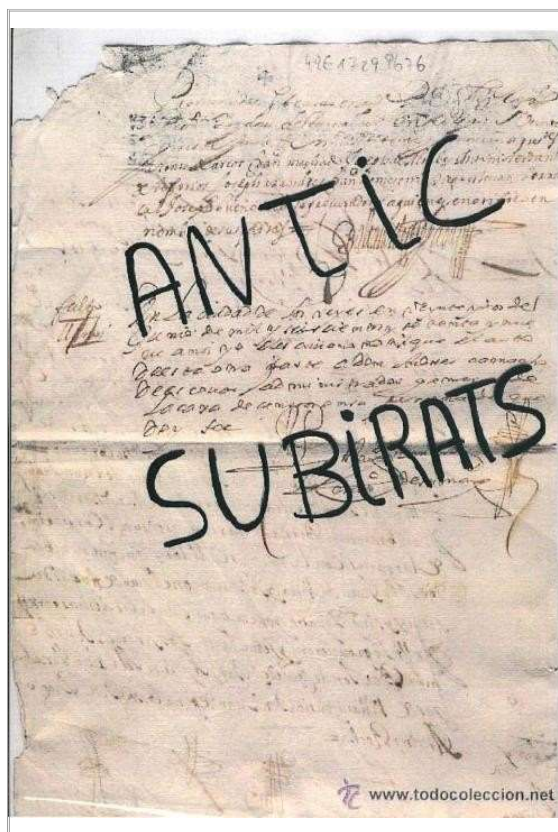
